13th Rural Technology Mela



NIRD&PR organized 13th Rural Technology and Crafts Mela from 8th to 12th January 2015 in the main campus. The mela was formally inaugurated by **Dr. M V Rao, IAS, DG, NIRD&PR** on evening of 8th January. This is an annual feature in NIRD&PR with a host of festivities in the campus. Artists and Crafts persons from almost all the states participated in the mela. Reportedly, in five days mela all of them put together made a sale crossing Rs. 1.5 crores. Besides the exhibition, sales, establishing new contacts and renewing old one aspects well-planned. 'Cleanliness of the mela venue was given at most importance. About 20,000 people visiting mela every day. Food stalls were also arranged in the mela, which had high chances of generating a lot of waste – in terms of used paper plates, paper cups etc. Cleanliness action taken were (i) Swachh Bharat logo and message were displayed at all the places; (ii) there was a team of student-volunteers to pick up on regular basis paper plates or tea cups. Anyone throwing waste irresponsibly had to undergo a 5-7 minute 'lecture' on **Swachh Bharat** by volunteers. There were cultural programmes on all the five days of mela in the evening which includes folk dances, puppet shows, mimicry's, orchestra, magic show, stunts, dramas etc. by well known artists and personalities. On concluding day Dr. M V Rao issued participation certificates to all the stall holders besides presenting the best stall certificates to some of them. Editorial**Closure Clause for Infrastructure Development of RSETIs**

Dear Readers,

You are aware that RSETI Scheme was launched by MoRD, Gol in early 2009. The scheme has completed 6 years of its existence. On review of progress in construction of RSETI buildings, it is observed that progress is far from satisfaction. After a thoughtful consideration, MoRD has decided to put a closure clause for infrastructure development aspect of RSETIs. Accordingly, MoRD vide their letter No.I-12011/02/2015-NRLM (RSETI), dated.6/4/2015 has communicated that :-

- With effective from 1.4.2015 new request for Administrative Approval will not be entertained.
- In respect of those RSETIs where administrative approval is accorded, no infrastructure grant shall be released, if the construction work is not initiated on/or before 30.6.2015.
- The ongoing construction shall be priority for the Banks and construction must be completed latest by 30.6.2016, failing which Banks will forfeit eligibility to receive balance grant unspent amount, if any, have to be refunded back to NIRD&PR.
- In respect of RSETI where construction yet to start, the issues must be sorted out, so as to commence the actual physical construction on/or before 1.7.2015, failing which Banks are liable to refund the funds back to NIRD&PR.

In view of these guidelines, **All Banks are requested** to take note of the above & expedite construction of RSETI buildings.

Allahabad Bank

Shri R N Mohanty GM (PSC & FI), Shri Ajay Kumar Srivastava, FGM, North Central (Lucknow), Shri K N Janardana, CPC, Shri O N Bansal, PD RSETI, NIRDPR, Shri K P Singh, SPC, UP(East), Shri C P Gupta, SPC, (UP Central), Head Office representatives and 19 RSETI Directors, Zonal Heads of Lucknow, Kanpur, Allahabad, Mirzapur, Sitapur, Lakhimpur-Kheri, Gonda, Bahraich and Hamirpur were also present in the inaugural session. Shri B N Sahoo, Principal STC welcomed participants and guests. Shri Mohanty, GM stated that the fundamental objective of the RSETI is to develop entrepreneurship skills among unemployed rural and semi-urban youths particularly from BPL families who could not have access to higher/professional education. To make the RSETIs more vibrant and result oriented, he outlined that (i) training programme should be prepared as per suitability and requirement of local area, (ii) trainees should be provided required support in preparation of project reports, (iii) local BMs are to be sensitized, (iv) Image building of the RSETIs, (v) to invite DM, ZMs and local BMs during the training and (vi) to make RSETIs as "Centre of Development". Shri A K Srivastava FGM, Lucknow proposed vote of thanks and advised all the Zonal Heads to monitor the RSETIs like branches of Bank.

Shri Janardhana, CPC reviewed the performance of each RSETI individually and outlined suggestions for improvement of their functioning. He suggested to avoid off campus programme as far as possible. Shri O N Bansal PD RSETI expressed his concern for not starting construction work at Satna, Chitrakoot, Hazaribagh, Godda and Dumka RSETIs where funds has already been released, but construction work has not yet been started. BoM RSETI Nagpur, Maharashtra

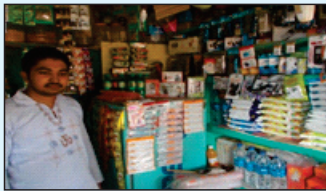
