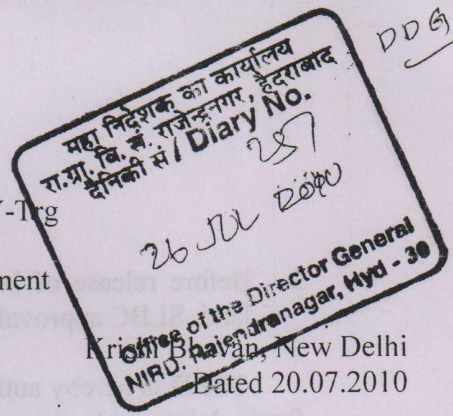

2. In the case of RSETIs Dandigul, NIRD should obtain a copy of the land allotment order before release of Infrastructure funds.

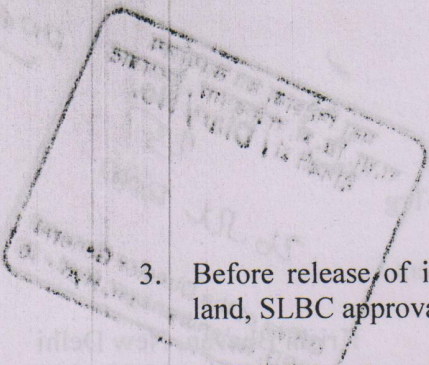
