I am directed to convey the sanction of the President of India to the release of Rs.13.00 crore to National Institute of Rural Development, Hyderabad for construction of 15 Employment Training Institutes as per statement attached.

NIRD, Hyderabad will release the funds to the banks subject to following terms and conditions;

- 1. The proposal should have the approval of NIRD, Hyderabad.
- 2. NIRD would release the funds to the implementing banks subject to (a) signing of MoU (b) Commitment regarding SLBC approval and (c) possession of land (d) being in a state of preparedness to undertake construction within 2 months of receipt of first installment.
- 3. The release will be in 2 installments (50% each) depending upon the progress of the work.
- 4. Assets register will be maintained for assets created out of financial assistance from Government of India.
- The amount will be held in an interest bearing "Corporate Liquid Term Deposit (CLTD)". 5. NIRD would be paid administrative fee at the rate of 1% of total funds transferred payable out of interest accruing on the account (CLTD). The remaining amount of interest accrued on this account shall be utilized for future assistance for similar venues.
- 6. NIRD will obtain Utilization Certificates (UCs), Balance Sheets and Audit Report from the implementing agencies as per time schedule prescribed in Guidelines for RSETIs and forward the same to the Ministry with certification.

- The NIRD shall furnish periodical reports about the progress of the setting up of Institutes, 24. expenditure incurred out of infrastructure fund and such other progress statements as may be prescribed or called for by the Govt. of India.
- The assets acquired wholly or substantially out of this grant should not be disposed of or 25. encumbered or utilized for the purpose other than those for which grant has been sanctioned without the prior sanction of the Govt. of India.
- The release of RSETIs advance payment is subject to adjustment through submission 26. expenditure statement viz. UCs and A.R. from a Chartered Accountant duly attested by certified authorities within a period of six months after release of final installment of infrastructure fund.
