**Subject:-** Release of 2<sup>nd</sup> installment of Infrastructure grant to NIRD, Hyderabad for construction of building of **Eleven (11)** RSETIs in various States-reg.  
Sir,

I am directed to convey the sanction of the President of India to the release of an amount of **Rs.5,10,17,000.00 (Rupees Five Crore Ten Lakh Seventeen Thousand only)** as 2<sup>nd</sup> installment of Infrastructure grant to National Institute of Rural Development (NIRD), Hyderabad for construction of building of **Eleven (11)** Rural Self Employment Training Institutes by Sponsoring Banks as **specified in Annexure**. The amount of 2<sup>nd</sup> installment has been calculated as below:

2. NIRD, Hyderabad will release the funds to the sponsoring Banks subject to following conditions:-

- I. NIRD to ascertain that no other funds have been released to Sponsoring Banks as second installment.
- II. The Sponsoring Banks shall commence utilization of funds within 2 months of receipt of funds.
- III. NIRD shall monitor the progress of the work and furnish periodical reports on progress of work .
- IV. An asset register shall be duly maintained for the asset created out of the funds released. Further any asset created/ acquired wholly or substantially out of these funds shall not be disposed off or encumbered or utilized for any other purpose than for which the funds have been sanctioned.
- V. NIRD will obtain UC, in prescribe format balance sheet and audit-report from Sponsoring Banks.
- VI. The amount shall be held in a separate interest bearing "Corporate Liquid Term Deposit (CLTD)"bank account. NIRD would be paid administrative fee at the rate of 1% of total funds transferred payable out of interest accruing on the account (CLTD). The remaining amount of interest accrued on this account shall be utilized for future assistance for similar venues.
