Dr Rao invited successful trainees for exposure visit to NIRD to see the Rural Technology Park. While complementing the institute for extending good services to the rural poor, he advised the Director to send the institute trainers for advanced training at NIRD.

## **Grassroots level Entrepreneurs in India**

Dear Readers,

There is a great hidden talent in Indian youth. Every youth has a entrepreneurial qualities. What is required is to harness the hidden entrepreneurial quality by giving a little skill development and hand holding support for the initial period. I would like to quote a real life story of a youth from Mumbai.........

"......A greater 'hole in the wall' and a small fading sign on the top saying "Cellphoon reapars" barely visible. I was on my way to buy a new Blackberry. My innate sense of adventure (foolishness) made me stop my car and investigate. A shop of not more than 6 feet by 6 feet. Grimy and unclean. I asked the boy standing there:

- "Can you fix a blackberry?"
- "Of course, show me"
- "How old are you"
- "Sixteen"

Bullshit. He was not more than 10. Not handing over my precious blackberry to a 10 year old in unwashed and torn T shirt and pajamas'! I thought if I buy a new one, they would extract the data for me. The boy asked me:

"What's wrong with it?"

"Well, the roller track ball does not respond. It's a kind of stuck."

He grabbed it from my hand and looked at it and said:

"You should wash your hands. Many customers have same problem. Roller ball get greasy and dirty, then no working"

Look who was telling me to wash my hands. He probably has not bathed for 10 days; I wanted to snatch my blackberry back. Meanwhile he said.

"You come back in one hour and I will fix it"

I was not prepared to leave my precious data in unwashed kid's hands. Any way I asked him.

- "Who will fix it?"
- "Big brother"
- "How big is 'big brother?"
- "Big .... umm ..thirty"

Then suddenly big brother walks in. 30??? He is not more than 19.

'What problem?' He said grabbing the phone from my greasy hand into his greasier hand.

"Normal blackberry problem". I replace with original part now and said you must wash your hand before you use this"

19 year old big brother rummages through a dubious drawer full of junk fishes out a spare roller ball packed in cheap cellophane wrapper. Original part? I doubt it.

But by now I was in the lap of the real India and there is no escape as he fishes out a couple of screw drivers and sets about opening my Blackberry

- "How long will this take?"
- "Six minutes"

After spending the whole morning trying to find a Blackberry service centre and getting vague answers about sending the phone for an assessment that might take a week, I settle down next to his grubby cramped work space. At least I am going to watch all my stored data vanish into virtual space. I was not breathing easy anyway. I was forced to stop myself grabbing my precious blackberry back and making a quick escape.

But in exactly six minutes kid handed my blackberry back. He changed the part, cleaned it and serviced the whole phone. Taken it apart, and put it together. As I turned the phone on there was a horrific 2 minutes whether the phone would not come on. I looked at him with such hostility that he stepped back.

- "You have more than thousand phone numbers?"
- "Yes"
- "Backed up?"
- "No"
- "Must back up. I do it for you. Never open phone before backing up"
- "You tell me that now?"

But then the phone came back in my hand and my data were still there. Everyone watching laughed and clapped. This was becoming a show." **A six minute show**".

I asked him how much?

"500 rupees" I thought \$ 10 as against \$ 600 I was about to spend on a new blackberry or a couple of weeks without my phone. I was shocked at his 'high price 'but calmly paid him. "Do you have an "i phone?" Even the new '42 one?

"No, why

"I can break the code for you and load any 'app' or film you want. I will give you 10 films on your memory stick on this and change every week for a small fee."

I went home having discovered that true entrepreneurship lies at what we call the "Bottom of the Pyramid".

I smiled at the future of our country. If we could harness this potential.....
