**Editorial**

**Closure Clause for Infrastructure Development of RSETIs**

You are aware that MoRD has put a closure clause for infrastructure development of RSETIs vide letter No.I-12011/02/2015-NRLM (RSETI), dated.6.4.2015. The same was circulated to all the concerned. A brief on closure clause was also published under editorial in our January - March issue of Enterprise i.e. RSETI quarterly news letter.

Subsequent to the above directives MoRD has made some exception with regard to administrative approvals purely based on merit of individual case. In this quarter we have released 1<sup>st</sup> installment of infrastructure grant to some of the RSETIs/ Banks based on their undertaking that Bank is in preparedness to start the construction. In all such cases construction should start immediately without further delay.

We have called for a detailed statement on construction status in **revised format as on 30.6.2015**. On receipt of statements, in-depth review will be done and necessary action may be initiated which includes recall/ refund of grant released if construction work has not started, whatever may be the reason.

The Bank has to give top priority to the construction of RSETI building and to ensure that ongoing construction should be completed latest by 30.6.2016, failing which 2<sup>nd</sup> installment of grant may not be released.

We are happy to note that there is a spurt of construction activities during this quarter. It is evident from the fact that Bhoomi puja/ Foundation laying was done at large number of RSETIs. This issue itself has information about the Bhoomi puja of large number of RSETIs. At the same time we have also received the information about fresh allotment of the land, handing over the possession of land, execution of the lease deeds, approval of the plans etc in respect of many RSETIs.

After completing the training Imran went back to at village Jawas with only ₹ 200 in his pocket. He started repairing pump-sets & rewinding motors with the help of the toolkit provided by the institute. Today, Imran is earning ₹ 14,000 per month and aims to expand his enterprise further.



## Canara RSETI Erode, Tamilnadu

Smt. S Saraswathi lives in village Chithode. She studied up to 12<sup>th</sup> standard. Her husband is working in an export company. She is blessed with two children who are studying. Before training, she was selling sarees, but her income from saree business & husband's income was not sufficient. So she decided to learn tailoring to have more income. She heard about Canara RSETI through her friend. She applied and attended 21 days training in Dress Designing for Women. During training, she learnt stitching of chudidhar, blouse, school uniform, nighties & petty coats. After training, she mobilized capital of ₹ 50,000 (own fund ₹ 25,000 and loan from DCC bank ₹ 25,000) and started a tailoring shop. Now she is a pride owner of tailoring shop, engaging two assistants. She is earning monthly income of ₹ 7,000 after meeting all expenditures.

Ms. Sandhya belongs to a middle class family. She realized that with limited land holding it is not possible to fulfill basic needs of life. She wanted to start her own business. Through an EAP, she came to know that different trainings are organized by RSETI for unemployed youths free of cost. She opted for beauty parlour training in view of the fact that there are only two beauty parlours in her village. It was amicable learning experience for her during the training. She decided & started her parlour from home in the name of "Sandhya Beauty Parlour". At present, she earns ₹ 9,000 per month. She wants to do an advance course in Beauty Parlour Management.
