**Subject:-** Release of Infrastructure fund to NIRD, Hyderabad for setting up of **Seven (7) RSETIs** in various States-reg.

Sir,

I am directed to convey the sanction of the President of India to the release of an amount of **Rs.3,31,28,924.00 (Rupees Three Crore Thirty One Lakh Twenty Eight Thousand Nine Hundred Twenty-Four only)** towards 1<sup>st</sup> installment of Infrastructure Funds as grant-in-aid to National Institute of Rural Development (NIRD), Hyderabad for construction of **Seven (7) Rural Self Employment Training Institutes** by Implementing Banks as **specified in Annexure.**

2. NIRD, Hyderabad will release the funds to Implementing Banks subject to following conditions:-
- NIRD to ascertain that no other funds have been released to Implementing Banks as second installment.
  - The Implementing Banks shall commence utilization of funds within 2 months of receipt of funds.
  - NIRD shall monitor the progress of the work and furnish periodical reports on progress of work .
  - An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of this funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.
  - NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.
  - The funds released would be maintained in a separate Bank account with CLTD by NIRD and NIRD is entitled to an administrative fee at the rate of 1% total funds out interest accruing on account of CLTD.

There is no UC Pending from Implementing Banks/ NIRD for the Infrastructure fund given by Ministry earlier.
