Sir,

I am directed to convey the sanction of the President of India to the release of an amount of **Rs.4,80,00,000.00 (Rupees Four Crore Eighty Lakh only)** towards 1st installment of Infrastructure Funds as grant-in-aid to National Institute of Rural Development (NIRD), Hyderabad for construction of **Ten (10)** Rural Self Employment Training Institutes including ~~balance~~ payment of 1st installment to ~~RSETI~~ RSETI by Implementing Banks as **specified in Annexure.**

2. NIRD, Hyderabad will release the funds to Implementing Banks subject to following conditions:-
 - I. NIRD to ascertain that no other funds have been released to Implementing Banks as second installment.
 - II. The Implementing Banks shall commence utilization of funds within 2 months of receipt of funds.
 - III. NIRD shall monitor the progress of the work and furnish periodical reports on progress of work .
 - IV. An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of this funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.
 - V. NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.
 - VI. The funds released would be maintained in a separate Bank account with CLTD by NIRD and NIRD is entitled to an administrative fee at the rate of 1% total funds out interest accruing on account of CLTD.

5) The accounts of the grantee institution or organization shall be open to inspection by Internal Audit of the Pr. Accounts, in terms of Rule 211(1) of GFR 2005 or Comptroller and Auditor General. There is no UC Pending from Implementing Banks/ NIRD for the Infrastructure fund given by Ministry earlier.
