 - III. NIRD shall monitor the progress of the work and furnish periodical reports on progress of work.
 - IV. An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of these funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.
 - V. NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.
 - VI. The funds released would be maintained in a separate Bank account with CLTD by NIRD and NIRD is entitled to an administrative fee at the rate of 1% total funds out of interest accruing on account of CLTD.


