I am directed to convey the sanction of the President of India to the release of an amount of **Rs.40,00,000.00 (Rupees Forty Lakh only)** towards 1<sup>st</sup> installment of Infrastructure Funds as grant-in-aid to National Institute of Rural Development (NIRD), Hyderabad for construction of **One** Rural Self Employment Training Institutes payment of 1<sup>st</sup> installment to Rajpipla RSETI in Gujarat State. The funds being released is calculated as follows:

2. NIRD, Hyderabad will release the funds to Implementing Bank subject to following conditions:-
- I. NIRD to ascertain that no other funds have been released to Implementing Banks as second installment.
  - II. The Implementing Banks shall commence utilization of funds within 2 months of receipt of funds.
  - III. NIRD shall monitor the progress of the work and furnish periodical reports on progress of work .
  - IV. An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of this funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.
  - V. NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.




