Subject:- Release of 1st tranche of 1st installment of Infrastructure fund to NIRDPR, Hyderabad for setting up of **Four** RSETIs JKB Baramulla, JKB Kupwara, JKB Shopian, JKB Poonch in Jammu and Kashmir State-reg.
 Sir,

I am directed to convey the sanction of the President of India to the release of an amount of **Rs.78,23,000.00 (Rupees Seventy-eight Lakh Twenty-three Thousand only)** towards 1st tranche of 1st installment of infrastructure grant-in-aid amounting to National Institute of Rural Development & Panchayati Raj (NIRD&PR), Hyderabad for RSETIs JKB Baramulla, JKB Kupwara, JKB Shopian, JKB Poonch for the year 2020-21, to be released in two tranches of 50% each. The second tranche may be released after utilization of 60% of the total funds available. The funds being released is calculated as follows:

2. NIRD, Hyderabad will release the funds to Implementing Bank subject to following conditions:-
 - I. NIRD to ascertain that no other funds have been released to Implementing Banks as First installment of Infrastructure grant of above four RSETIs.
 - II. The Implementing Banks shall commence utilization of funds within 2 months of receipt of funds.
 - III. NIRD shall monitor the progress of the work and furnish periodical reports on progress of work.
 - IV. An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of this funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.
 - V. NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.



The amount of **Rs.78,23,000.00 (Rupees Seventy-eight Lakh Twenty-three Thousand only)** may be transferred to the **National Institute of Rural Development & Panchayati Raj (NIRD&PR)**, Hyderabad, Telangana through RTGS in Bank Account No.52040475313, State Bank of India, Branch Code No. 020965, IFSC Code No. SBIN0020965.

5. It is certified that there are no utilization certificates due from National Institute of Rural Development & Panchayati Raj (NIRD&PR), for the previous funds granted for this project by the Ministry for RSETIs.
