As a part of the admission process, you have to make the following arrangements to pay the first Trimester Tuition fee and other Deposits totaling **Rs.50,000/-** through online. The last date for payment of the first trimester fee is **07.08.2020**.

The Total Programme Cost is **Rs.5,70,000/-**. This amount include Tuition fee, Board and Lodging cost and caution deposit in Two years.
