

ABOUT THE TRAINING PROGRAMME

India is the second most populous country in the world, with a population of 1.37 billion. Despite rapid economic growth in the last two decades, a large section of the population in India, particularly women and children in rural areas suffer from malnutrition. Malnutrition contributed one-third to one-half of child deaths in India, and the annual economic losses due to malnutrition levels is estimated to be about 3 per cent of country's GDP.

In India, nearly 60 per cent of the rural population is dependent on agriculture for its livelihood. There is a strong linkage (direct and indirect) between agriculture production systems in rural areas and the nutritional status of the population that depends on it. In order to achieve food and nutritional security, it is important to identify and understand the issues around agriculture - nutrition linkages, its constraints and potential in achieving better nutritional outcomes.

There are demand and supply side factors that contribute to better nutritional outcomes. Over years, we have made significant efforts in the case of supply side factors governing nutritional outcomes, primarily through food and nutritional security schemes like Public Distribution System (PDS), Mid Day Meal scheme and Integrated Child Development Services (ICDS) etc. However, to improve the nutritional status of vulnerable population, we need to focus our efforts in influencing demand side factors as well, and integrate the demand and supply side efforts. To achieve this, we need to develop frameworks and modelsthat integrate the agriculture production system with the ongoing food and nutritional security programmes.

In this context, the training programme aims to make participants understand the development challenges due to malnutrition, major programmes and policies to address the issue of higher levels of malnutrition particularly among women and children, importance of agriculture production systems in influencing nutritional status of the population and the specific pathways through which agricultural nutrition linkages operate. The programme

will also create awareness about various models adopted by various agencies across the country in improving the agriculture-nutrition linkages.

OBJECTIVES OF THE PROGRAMME

The major objectives of the programme are to,

- To understand the development challenges in nutritional status of population in India.
- To familiarise with the programmes and policies for addressing malnutrition in the country.
- -To understand the role and function of agricultural production systems in determining nutritional outcomes.
- -To introduce sustainable models for improving agriculture nutrition linkages which will contribute to better nutritional outcomes.

OUTCOMES OF THE PROGRAMME

At the end of the training programme, the participants will get a better understanding of

- a) the development challenges due to malnutrition and the various strategies and programmes to address that.
- b) the role and importance of agriculture production systems in determining nutritional status and the pathways through which it influences the nutritional outcomes of a population.
- c) the various models that are emerging and which can be adopted with necessary modifications for augmenting the agricultural-nutrition linkages for better nutritional outcomes.

TRAINING METHODS

Training methods will comprise of lectures, group discussions, and presentations. Presentations on good practices/ successful models will be imparted. There will be exposure visits and interactions with experts working in this domain.

RESOURCE PERSONS

Besides the in house faculty members who have long years of experience, eminent speakers/resource persons from outside will also be invited for taking sessions.

TARGET AUDIENCE

Officials from Depts. of Women and Child Development, Agriculture and Rural Development, CSR functionaries, NRLM, SRLM, SIRDs, ETCs, Research Scholars and NGOs.

There is No Training Fee for the programme.

ACCOMMODATION &TRAVEL

This program is residential in nature and NIRD&PR will provide accommodation in its Guest House and will bear boarding and lodging charges for the participants during the training. However, to and fro travel expenses of the participants attending the training program must be borne by their nominating / sponsoring agencies.
