Training on Preparation of Comprehensive Village Development Plan

Towards achieving all-round development of gram panchayat 28-30 June 2021

## **BACKGROUND**

The PRIs are to be responsible for plan and implement the schemes for economic development and social justice. Gram Panchayats need to develop a five-year "Shelf of Projects" followed by annual plans which involves the identification, ranking and preparation of projects of development activities. In order to identify priority projects for improving rural accessibility, the Gram Panchayat needs to have an adequate overview of access to funds and infrastructure related to social and economic development. Followed by the constitutional provisions, Govt. of India has created an enormous opportunity for responsive local governance through the Central Finance Commission for Gram Panchayats. In addition, the MGNREGS which is the most important flagship programme of the Ministry of Rural Development allocates around 50,000 crores every year for rural development schemes which are implemented by the gram Panchayats. Further, the panchayats also receives SFC grants, state government scheme funds and own source revenue. One of the basic prerequisites for management of funds of this scale needs a comprehensive development plan. In the context of the Constitutional mandate, this plan should be a participatory, involving the community, particularly the gram sabha. The GP development plan should have clear components of addressing vulnerabilities of poor and marginalised section and their livelihood opportunities through an integrated poverty reduction plan with converge of all the schemes at GP level. It needs preparatory and capacity building efforts to be taken up at GP levels. For this purpose, this programme has been designed to suit elected representatives and officials of GP.

- To make participants to understand on the need and importance of preparation of long term / comprehensive development plan and annual plans.
- To give insights on preparation of village draft development plan
- To discuss on the successful case studies on comprehensive village development.
- Panchayat Financial Autonomy through OSR
