National Level Advisory Committee - RSETI Meeting



Second meeting of reconstituted National Level Advisory Committee (NLAC) RSETI was held on 30th August 2016 at Unnati, Krishi Bhawan, New Delhi under the chairmanship of **Shri Amarjeet Sinha, IAS, Secretary (RD), MoRD. Dr. D Veerendra Heggade, Co-Chairman, NLAC RSETI** and Shri Atal Dulloo, Joint Secretary (RL) was also present. The meeting was attended by Senior Officials from RBI, SIDBI, NABARD, CAPART and Senior executives from various banks & SRLMs apart from NIRD&PR, NACER & NAR.

Shri Dulloo welcomed Dr. D Veerendra Heggade and other participants of the meeting. Dr. Heggade in his address requested Secretary MoRD for enhancement of the infrastructure grant of Rs.1 crore; enhancement of the rate of reimbursement of training expenses from the existing Rs.200/-per day per candidate to Rs.300/- per day per candidate and to expedite reimbursement of long pending training expenses of BPL candidates to the concerned RSETIs. Secretary RD, in his address assured Dr. Heggade that these issues would be looked into. The NLAC discussed other various issues related with functioning & monitoring of RSETIs, which ministry has taken the note off. Shri T C Nautiyal, IFS, Deputy Secretary (RL) presented a power point on the achievement of RSETIs.

Inauguration of SBH RSETI Parbhani, Maharashtra



SBH RSETI Parbhani's new building was inaugurated by **Shri Santanu Mukherjee**, **MD of the Bank** on 1st August, 2016. A number of district & bank officials were present on the occasion. The RSETI Director informed that the institute was established on 1.10.2011. Construction Status of RSETIs

It is heartening to note that construction of RSETI buildings has further picked up during the year 2016-17, we have made a quick review of construction status on 30.9.2016 and are happy to inform all the stake holders of the RSETIs that as on 30.9.2016 construction of 140 RSETI buildings are completed by various banks across the country and another 106 buildings are nearing completion. Thus, we hope that by the end of this financial year more than 250 RSETI buildings will be ready. The major contributors are Bol, BoB, CBI, Canara Bank, Dena, SBI, SBH & PNB. When we look at state wise progress M P state stands at No.1, out of total 50 RSETIs/Districts construction is completed at 27 locations and nearing completion at 14 locations. The other States where construction progress is satisfactory are Chhattisgarh, Gujarat, Jharkhand, Odisha, Telangana etc. We are happy to inform that construction progress has picked up in the state of U.P. during this financial year which was lagging till last year.

As per the "Closure Clause Guidelines" issued by MoRD vide their letter No.I-12011/02/2015-NRLM (RSETI), dated. 18.5.2016 time limit for claiming the second instalment is upto 30.6.2017. Hence all the banks are requested to ensure submission of claims for second instalment, after utilization 60% of funds released for first instalment along with U.C. & 2-3 photographs of latest construction status.

Central Bank of India

Central Bank of India organized 5th round of conclave for their RSETI directors on 27th & 28th April, 2016 at CBOTC, Kolkata. The conclave was inaugurated by Dr. R C Lodha, ED of the Bank by lightening the lamp along with Shri K N Janardhana, NDR, Shri O N Bansal, PD RSETI, Shri A P Dwivedi, CEO, CBI-SUAPS. Shri V Kalkundri, Director, NACER, Shri S K Pal, Manager, NSFDC, Shri P P Nachankar, AGM & Nodal Officer RSETIs, Principal, CBOTC, Kolkata and 42 RSETI Directors participated in the conclave. Shri A P Dwivedi welcomed the guests & dignitaries on behalf of bank and trust. Shri Janardhana highlighted the objectives of the conclave & informed that "Cent RSETIs" have performed exceedingly well during the FY 2015-16. Govt. of India has fixed a target of 4.25 lacs candidates to be trained for the year 2016-17 which shall not be difficult to achieve. Shri Bansal informed that Central Bank of India is number one amongst all Banks in creation of RSETI's infrastructure. NIRD&PR has requested MoRD to recognize the efforts of the Bank on RSETI Diwas. Shri Bansal reviewed RSETI wise status of allotment/possession of the land and progress in construction of RSETI buildings.



Dr. Lodha in his key note address emphasized that he is attaching highest priority to RSETI programmes. He said this conclave is not a compliance conclave, but a conclave to assess the ground realities and to ensure achievement of RSETI objectives. He advised RSETI Directors to conduct need based training programmes. He suggested developing some RSETIs having specialization in imparting training on certain activities requiring higher level of skill. He concluded by saying that Directors should work on TRIP strategy i.e. Training, Review, Introspection and Planning. Shri Pal made a presentation on various schemes of NSFDC. He requested the Directors to help SC trainees in securing loan from the bank and benefit of subsidy from NSFDC.

Union Bank of India

Shri Bansal discussed the issues related to land allotment and construction of RSETI buildings. He assured that the matter will be taken up with State governments, wherever RSETIs are facing problem in land allotment. Each RSETI Director presented performance of his RSETI. A through review of each RSETI was done by Shri Janardhana & Shri Kalkundri.
