### Book Release - Success Stories from RSETIs

RSETIs scheme was launched in the early 2009, as a component of NRLM with a soul objective of skill development and capacity building of rural unemployed youth and to motivate & guide them to establish their own micro enterprises by providing hand holding support for a minimum period of two years. As on date there are 565 functional RSETIs across the country. These RSETIs have trained more than 5 lakh youth. The success of RSETIs is measured in terms of settlement of the youth in self employment. Over the years there are many success stories from RSETIs across the country which may motivate other unemployed youth to go for self employment.



In the above back drop NIRD as a Nodal Agency to implement the programme, made an attempt to collect and publish a few success stories from various RSETIs in a book form titled **"Success Stories from RSETIs"**. The purpose of this book is to share the success of unemployed youth with the intervention of RSETIs among its various stakeholders and more so with unemployed youth. The book was formally released by **Sri S Vijay Kumar, IAS, Secretary, MoRD, Govt. of India** on 03<sup>rd</sup> May, 2013 in a glittering function at NIRD in the presence of **Dr. M V Rao, IAS, DG, NIRD** and august presence of all the Professor & Heads and Faculty members. **Editorial****Infrastructure for RSETIs***Dear Readers,*

As per original guidelines of MoRD each RSETI is to be allotted one acre of suitable land free of cost by state govt. / dist. administration for the construction of RSETI building. However, some of the states particularly hilly terrain states expressed their difficulty in allotting one acre suitable land. In such cases MoRD has relaxed the guidelines that a minimum of 0.5 acres land is to be allotted. As on date there are 570 functional RSETIs, out of which as many as 415 RSETIs have been allotted the land i.e. 75% RSETIs got the land. Out of this 340 RSETIs have also taken the possession of the land. But it is highly disappointing to note that construction work has started only at 80 RSETIs and buildings completed so far are only 30. This particular aspect needs special attention of all the sponsoring banks and related officials. However, it is heartening to note that in recent past there is a momentum in construction process, it is evident from the fact that as many as 280 RSETIs have appointed the Architect and the process of getting approval from different authorities is in progress.

It is worthwhile to mention that each RSETI should have a minimum of 8000 sq feet constructed area which includes Directors' Room, Office Room, Two Class rooms, Two work sheds, One computer lab, Two dormitories one each for male & female, a Common dining hall & kitchen, Two guest rooms etc. You are aware that MoRD is providing one time infrastructure grant of ₹.1.00 crore through NIRD for this purpose. Many of the banks expressed their difficulty that 8000 sq feet construction with all facilities is not possible with the available grant and it needs enhancement. The matter was discussed in last National Advisory Council of RSETIs in which in principle it was agreed that infrastructure grant should be linked with CPWD rates but the final decision on this issue is yet to be taken. Hence, as on date maximum grant available is ₹. 1.00 crore only. Further due to undue delay in starting the construction process by the banks after release of 1st instalment, MoRD has decided that henceforth, 1st instalment of the infrastructure grant will only be released once banks give an undertaking that bank is in preparedness to start the construction within two months from the date of release of 1st instalment. The state of preparedness includes appointment of architect, preparation of plan & estimates, obtaining NOCs and approval from the appropriate authorities. MoRD is also thinking to recall the amount already released if the construction of the building is not started within reasonable time. You all will agree that proper infrastructure is the key to successful running of RSETIs and to ensure quality training.

**In view of the above, let us declare the current year i.e. 2013-14 as the year of infrastructure. We should aim that minimum of 100 RSETI's building's should be ready by the end of this year and the construction process should start at all the remaining RSETIs, where the land is allotted and possession is taken.**
