Editorial

Skilling Rural Youth

Dear Readers.

Over seventy percent of our population lives in rural areas. As per the estimate roughly fifty percent rural population is below poverty line. As we know poverty is the byproduct of unemployment. Out of total rural population about fifty percent are youth in the age group of 18 to 35. In rural areas mostly people are engaged in agriculture and allied activities to earn their livelihood. But in today's context, as we know employment potential in agriculture has dried. Further school drop outs are not willing to do labour work in agriculture. In this contest rural youth are looking for alternative job opportunities outside agriculture but due to lack of proper skill they are not able to get job opportunities in industrial and service sectors in urban areas. Thus the need of the hour is to train the rural youth in skill for employment, so that they can compete with their counter part in urban areas, and build a new future for themselves.

Hence rightly said, "Skilling rural unemployed youth is skilling India." Which will contribute to resurgent India. Skilling the youth in general and rural youth in particular have double advantage, one he/she can go for wage employment and alternatively he/she can go for self employment by establishing his/her own micro enterprise in the village or in a nearby town. Self employment has the power of generating more employment for other youth in the areas. Government of India has formed and implementing many schemes for skilling the youth in general and rural youth in particular. There are many govt. institutions and non government organizations, which are funded by govt., who are working for skill development of youth and preparing the youth for wage employment but there are only a few institutions who impart the skill for self employment. Rural Self Employment Training Institutes (RSETIs) is one such institution promoted by MoRD, Government of India.

MoRD, Govt. of India in association with state governments and Banks has established Bank led RSETIs in all most all the rural districts, across the country as a dedicated institution to ensure skill development and skill up gradation of BPL youth. RSETIs are offering short duration residential self employment trainings free of cost. Apart from training RSETIs also provide hand holding services to the trainees for two years to help him/her to establish a micro enterprise. In short, the philosophy of RSETIs is short duration training and long handholding.

Today we have 508 operational RSETIs across the country managed by 35 Banks. Put together these RSETIs have trained more than 2,20,000 youths and out of this approximately 1,30,271 youths are settled that is established their own micro enterprise and earning their livelihood. The numbers are growing.

Initiatives of SBI RSETI, Umaria in the L W E District of M P

Umaria district is located in the North East of Madhya Pradesh. This is one among the 78 most backward Left wing Extremists (LWE) affected districts, notified by the Planning Commission, Government of India. The Government of Madhya Pradesh is implementing Integrated Action Plan (IAP) scheme of Government of India to prevent the rural youth being enrolled as maoist cadres. The State Government has involved SBI RSETI Umaria in this difficult task.

Umaria RSETI was opened on 27.11.2010 with posting of Shri Jai Prakash Pandey, as Director in June 2010. Since then, Shri Pandey has taken up this assignment as a challenge and RSETI movement with passion. Umaria is amidst five declared wild conservation tiger reserve parks of Madhya Pradesh viz, Bandhavagarh (30 km), Kanha (170 km), Panna (250 km) and Pench (250 km).



When the RSETI was opened, the District Administration and RSETI jointly surveyed the extremist affected 17 sensitive villages to identify the potential tribal youth for entrepreneurship development training and their training needs. Since then, RSETI is conducting specific programmes exclusively for tribals. On the inauguration day itself, 7 day inland fishery training started. All the 26 fisheries trainees got one hectare pond from the District Collector, and free fish seedlings and fishnet from Fishery Department and also $\overline{\xi}$ 50,000/- loan from local banks leading to 100% settlement and 100% credit linkages.

The present Project Director RSETI, NIRD when visited Umaria RSETI in August 2011, suggested to have need based training like "Wildlife Tourist Guides for National Parks" and the "Barefoot Animal Care Taker cum Artificial Inseminator" as the Government veterinary doctors find it difficult to reach interior tribal hamlets. Accordingly, 16 day Tourist Guide training programme for National Parks under Tiger Project was conducted for 25 tribal youth. Let us know what the Project



Director, Tiger Reserve C.K. Patil, I.F.S. has to say on the success of this training "I have not come across this type of meaningful livelihood training for promoting wildlife tourism in India". The former Maharaja of Rewa kingdom and Ex-Minister of Government of Madhya Pradesh, Mr. Pushparaj Singh, who has authored several renowned wild life books, came as a resource person to guide the trainees. Rewa is the only kingdom in the world which has preserved the white tigers in the olden days. Now the same breed is preserved across many national parks in India under Wildlife Act. Soon after the training the trainees started earning average ₹ 400/- per day (in two shifts) as Wildlife Tourist Guide in the Bandhavgarh National Park. Thus there is 100% settlement. They earn while guiding the tourists as self employment in the service sector.



Normally, the tailoring programmes are conducted for women but at Umaria an exclusive tailoring programme was conducted for the tribal boys in the age group of 18 to 25 which is a unique feature, who opted tailoring as their livelihood.

On the valedictory day RSETI distributed certificates to the trainees along with 27 sewing machines, with the grant support under IAP scheme. Personality development is part and parcel of any training. But, the trainees coming from rural area and poor families require this more to integrate with mainstream society. As a part of RSETI training, the trainees at RSETI Umaria are motivated to take part in social activities such as cleaning of local rivers and railway platforms as shramadaan. Trainees were also motivated for serving the poor patients at the local hospitals and for delivering fruits to them by sacrificing their one day meal. This gives a strong message/feeling that the philanthropic activity should also become a part of good entrepreneurship qualities.

The tribal trainees are also motivated to donate blood which is the need of the hour to save the life of critical patients irrespective of their caste and creed. The District Administration invited RSETI trainees to participate in the 15th August Independence Day parade along with regular participants like police, home guards, scouts, school children, etc. This is the recognition to the RSETI Umaria. The trainees are also taught about the personal hygiene and medical care so that in case of need they can help their fellow villagers.

Looking at the success of RSETI, Umaria, one of the local leaders approached the District Collector saying that one Shri Pandey, a retired officer of SBI has opened a NGO under the name of RSETI and misusing the name of State Bank The District Collector responded to the leader in a lighter vein that he should have informed him earlier because he has already

Project Enterprise (NIRD initiative for Enterprise Creation)

Poverty and unemployment are the major problems in the rural areas and it is more so in tribal dominated areas and Left Wing Extremism (LWE) districts. There is lack of opportunities for wage employment in rural areas. Hence, NIRD realized that through skill development and capacity building, rural youth can be prepared to take up self employment ventures. Further, self employed person acts as a job generator. Thus, this will be a long term solution to rural unemployment and poverty.

In this backdrop NIRD took the initiative for skill development and capacity building of the youth particularly in tribal dominated areas and LWE affected districts under Project Enterprise. This project is implemented in association with a few reputed and well established CBOs who are already working in collaboration with one or the other Ministries and NABARD.

As on date NIRD has approved 40 skill development and capacity building programmes of 6 days to 60 days duration in different trades and activities such as mobile repairing, bee keeping, mushroom cultivation, vermi compost, food processing, manufacturing of utility items from handmade paper, repair of domestic electrical appliances, rewinding of electric motors, computer hardware, inverter and workshop, electrical house wiring, stone handicraft, domestic plumbing, multi-purpose mechanic, tractor servicing, two and four wheeler servicing, automotive repair, fabrication, spice processing and packaging, making of bamboo decorative, leather product, etc. All these programmes put together cover 990 participants. Implementing CBOs are providing hand holding services and are expected to ensure creation of enterprises by all the trainees/youth.

Out of 40 programmes approved till now 50% programmes are completed and the results are highly encouraging. CBOs are able to credit link most of the trainees to facilitate creation of micro enterprise by them. In some of the programme, there is 100% settlement. NIRD is monitoring the project very closely to ensure better results.

SBI Umaria RSETI has conducted 14 training programme (all residential) covering 385 rural youth, out of which 94% are tribal from remote areas, with settlement rate of 62%, during 1st year itself, which can be considered as a good success. The RSETI is also considering conducting "Barefoot Animal Caretaker cum Artificial Inseminators" training programme shortly. Thus Umaria RSETI stands a good role model for all RSETIs in the country.

The Institute got the label of 'Model RSETI' by Bankers Institute of Rural Development (BIRD) Lucknow. BIRD also provides support to the institute. The institute is one of the leading BSVS' in the country specifically indulging in the field of women empowerment. Successful entrepreneurs from the institute have participated in State level exhibitions like Lucknow Mahotsav and Saras Melas. Recently two of our entrepreneurs participated in International Trade Fair at New Delhi.

Due to some orthodox and superstitious belief, families of some of the trainees don't permit them to work. For such trainees, the institute conducts counseling programmes for the family members. One of the major concerns is financial constraints faced by trainees to start their own enterprises. Due to high interest rate they are scared of taking loans. For this the institute conducts counseling to create awareness amongst trainees to avail the loans from the banks.

The institute plans to reach out to all the rural people in Rae Bareli through entrepreneurship training programmes. To go beyond women empowerment, we are motivating our successful pass-out trainees for the development of BSVS ladies Welfare Club. This club is supposed to take over the health and hygiene problems, illiteracy and unemployment problems dwelling in the rural women.
