Release of Infrastructure fund as one time payment to NIRD, Hyderabad for setting up of 10 (Ten) Rural Self Employment Training Institute (RSETIs) located at various places as per annexure.

Sir,

I am directed to convey the approval of the President of India to the incurring of expenditure of Rs. 9.70 crore (Rs. Nine crore seventy lakh only ) by NIRD, Hyderabad towards one time grant assistance for creation of infrastructure for setting up of 10 (ten) Rural Self Employment Training Institutes (RSETIs). I am also directed to convey the approval to release of Rs.2.87 crore to NIRD Hyderabad for further release to the banks for setting up of 10 (ten) Rural Self Employment Training Institute (RSETIs) at various places in India as per details enclosed at Annexure. The balance amount of Rs.6.83 crore would be met out of funds already lying with NIRD, Hyderabad

As regards assistance to Mehsana (Gujarat) it is noted that the land has been allotted by the Zila Gram Vikas Agency Mehsana for setting up of RSETI. But no agreement/MOU has been signed to authorize the Dena Bank for its use in setting up of RSETI. Due authorization may be obtained for Dena Bank to use the said land for setting up RSETI and fresh proposal sent to this Ministry.

NIRD, Hyderabad will release the funds to the banks subject to following terms and conditions:

The proposal should have the approval of NIRD, Hyderabad. 1.

NIRD would release the funds to the implementing banks subject to (a) signing of MoU 2. (b) Commitment regarding SLBC approval and (c) availability of land /MoA.

The release will be in 2 installments (50% each) depending upon the progress of the work. 3.

Assets register will be maintained for assets created out of financial assistance from 4. Government of India.

The amount will be held in an interest bearing "Corporate Liquid Term Deposit (CLTD)". 5. NIRD would be paid administrative fee at the rate of 1% of total funds transferred payable out of interest accruing on the account (CLTD). The remaining amount of interest accrued on this account shall be utilized for future assistance for similar venues.

NIRD will obtain Utilization Certificates (UCs), Balance Sheets and Audit Report from the 6. implementing agencies as per time schedule prescribed in Guidelines for RSETIs and forward

the same to the Ministry with certification.

Implementing Bank shall utilize the funds for the purpose for which it is sanctioned as 7. mentioned in the MoU. No cost escalation will be permitted.

The funds released for the purpose should be maintained in a separate bank account. The 8. interest accrued on the amount deposited in the Bank would be used only for the purpose.

- 9. The NIRD shall furnish periodical reports about the progress of the setting up of Institutes, expenditure incurred out of infrastructure fund and such other progress of statements as may be prescribed or called for by the Govt. of India.
- 10. The assets acquired wholly or substantially out of this grant should not be disposed of or encumbered or utilized for the purpose other than those for which grant has been sanctioned without the prior sanction of the Govt. of India.
- 11. The release of RSETIs advance payment is subject to adjustment through submission of expenditure statement viz. UCs and A.R. from a Chartered Accountant duly attested by certified authorities within a period of six months after release of final installment of infrastructure fund.
