- IV. An assets register shall be duly maintained for any assets created out of the funds released. Further any assets created/ acquired wholly or substantially out of this funds shall not be disposed off or encumbered or utilized for any other than those for which the funds have been sanctioned.

V. NIRD will obtain UC, Balance sheet and audit-report from Implementing Banks.

VI. The funds released would be maintained in a separate Bank account with CLTD by NIRD and NIRD is entitled to an administrative fee at the rate of 1% total funds out interest accruing on account of CLTD.
